Levy rates for 2025-2026 are as follows:

Regular Levy – As determined by the Legislature per WV Code 11-8-6f.

Special Levy – As per renewal of November 6, 2022, effective the fiscal year beginning July 1, 2024, July 1, 2025, July 1, 2026, July 1, 2027, and July 1, 2028.
