Learning Loss - Dr. Branch had a handout for Board Members. There was a plan for the 35 instructional time that was lost in recent weeks. We are required by law to have 180 days of 36 instruction. We would be able to meet 177 days with a waiver of three (3) days. He explained the plan. 37 There would be two (2) weeks of after school and six (6) weeks of teachers using planning periods for 38 instructional loss. It would cost about \$50,000.
