

PART I. GENERAL EXPECTATIONS

The Lenore PK-8 agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will ensure that the required school level

 - The annual meeting will occur at the beginning of the new school term, and another on at the end of the second semester. An overview of the Title I Program, goals and the purpose of the Title I Services will be explained.
 - Parents will receive invitations to all parent trainings and workshops in a timely manner. They are encouraged to participate in the review/revision of the School Parent Involvement Policy.
 - The Title I staff will provide an explanation of the curriculum in use, and the County Instructional Coach will provide math workshops to provide information about the new math curriculum, forms of assessments utilized to measure student progress, and the proficiency levels students are expected to meet.
 - > Parents and grandparents will be encouraged to volunteer at the school.
- 4. The Lenore PK-8 shall provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet.
 - At annual informational meetings, the Title I staff will provide an explanation of the curriculum in use, for examples, Comprehensive Literacy and Standards Based Math. Forms of assessment utilized include PALS for K-2, State Interims, and Journeys and Envision Assessments to measure student progress.
 - > The proficiency levels of students are expected to meet on each assessment tool will also be discussed.
 - Parents will be kept up-to-date on student's progress using these sources: LMS(Learning Management System), Live grades, Progress Reports, Report Cards, Parent/Teacher Conferences by Phone/in-person, School Email, School's Facebook page and U.S. postal Service.

- 5. The Lenore PK-8 shall, at the request of parents, provide opportunities for regular meetings, held at flexible times, for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
 - Holding individual parent-teacher-student conferences virtually when requested.
 - Providing parents with appropriate materials to ensure academic success for their child.
 - Scheduling curriculum-based workshops which address parent concerns and needs.
 - Parents of children with disabilities will be given flexibility to attend meetings according to their schedule.
 - Parents will be kept informed in decisions regarding their student's education.
- 6. The Lenore PK-8 shall provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts, and reading by:
 - Individual student reports will be sent home to parents explaining their child's performance on the state assessment (West Virginia Summative Assessment).
 - Meetings when requested by the parents, will be held to inform how to analyze the results of the state assessment.
- 7. The Lenore PK-8 shall take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002):
 - Letters will be mailed from the central office personnel department to parents of children who have been taught for four (4) or more consecutive weeks by a teacher who is not fully certified within the meaning of term in section 200.56 of the Title I Final Regulation (67 Fed. Red. 71710, December 2, 2002).
 - The school principal will receive notification of a teacher who is not fully certified.
- 8. The **Lenore PK-8** shall provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described below
 - A. The state's academic content standards;

- E. How to monitor their child's progress; and

 - The staff will provide a link to parents on the school's webpage of the state's academic content standards for the appropriate grade level and the state's academic achievement standards.
 - Brochures of the state and local academic assessments including alternate assessments will be sent home to parents of participating students.
 - This year the first annual informational meeting will be in person, parents will be informed of the educational opportunities which exist under the requirements of Title I Part A. Parents will gain knowledge on how to monitor their child's progress as well as how to work with educators.
- The Lenore PK-8 shall provide materials and training to help parents work with their children in the areas of improving student achievement (including literacy training and using technology), child development, child rearing, and additional topics parents may request.
 - Virtual parent workshops and in-person meetings will be held on several topics which include literacy, technology, mathematics assessment, and child rearing practices.
 - Parents may request additional material or information on the above topics. All parent requests are given high priority. (List activities)
- 10. The Lenore PK-8 shall, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
 - Professional development in the form of recent scientifically based research articles will be held to educate school personnel on how to communicate with and work with parents as equal partners with valuable contributions, and how to develop positive rapport with them.
- 11. The Lenore PK-8 shall, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, and the Parents as Teachers Program, public preschool, and other programs. The school will also conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:



- The staff of Lenore PK-8, educational partners (Head Start), and community members will meet to plan transition from Head Start/Pre-school to Kindergarten.
- Head Start/Pre-School and Kindergarten staff will not conduct home visits at the beginning of the school term due to COVID. They will conduct phone conferences instead.
- 12. The Lenore PK-8 shall take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
 - The central office will work with Lenore K-8 to review printed materials to ensure that it is written in a simple language for all parents to understand.
 - All newsletters, letters, memos, brochures, and booklets will be distributed in a language which is easily understood.
 - Lenore Pk-8 special meetings and activities will be announced by utilizing the school's Facebook page, school's website, local newspaper, and other media sources.
